







Sample Comments

- We need to significantly upgrade the fitness room. It is terribly outdated, with equipment that doesn't work. We need modern digital machines that can be synced to our phones. We also need a new, modern tv in that room, one that works.*
- Groundskeeping... one of the reasons we bought originally was the combination of natural beauty and thoughtful and beautiful gardening and upkeep around entrances and along roads, etc. let's ensure we make the investment to keep it up!*
- There should be an automatic golf ball picker. It's a safer and easier option for people using the range. It's actually dangerous to ask people to pick up their own balls especially while others are hitting them.*
- Our trail network is the heartbeat of the community — the single most visible and defining expression of our values. It connects us to the land, to one another, and to the conservation ethos that underpins the development. The volunteer-led maintenance effort has been extraordinary, but we're now seeing signs of strain: backlog on upkeep, uneven trail quality, and gradual decline of features that once defined the character and craftsmanship of the system.*

5. *Some of the bridges along Nature's Walk have missing boards. I have really enjoyed the homeowners' parties, its a great opportunity to meet neighbors and create community.*
6. *Wildlife population*
7. *Construction traffic behind us once building starts on Packs Creek.*
8. *Need to closely monitor/control the activities of all builders in the community. At this point it seems to be a free-for-all with building taking place 7-days a week with no concern for existing residents. Additional transparency of what building activities are in the pipeline would also be helpful.*
9. *I would like to focus on affordably providing reliable infrastructure. If there are funds for more, great, if not, I do not want dues increased further.*
10. *Lighting at Breedlove and new settlers, and at the gate at new settlers is very soft and doesn't illuminate the road or gate very well*
11. *Secure Post Office*
12. *Saving the Fishing Shack*
13. *Would like a bigger exercise facility*
14. *Getting the green space at cow mountain finished. And getting the rock at entrance to cow mountain lit up for safety. Protecting the trails from unauthorized utv use (red trail in particular is getting utv use that I have seen - Need signage for this...I got into a debate with a homeowner using a utv on the red trail and they told me "it is not marked no utvs". Need to educate residents / remind them on UTV policy.*
15. *Would like to have recycle collection in Chinquapin*
16. *Would like to see all open burning band and enforced without the written approval of the board or their designee.*
17. *While I am disappointed in the quality of the amenities at Chinquapin, I believe we need to make sure that the systems that support residency (i.e. water, roads, infrastructure, safety & security) are in good order before we focus on the "nice to have" elements of our community. As an example, the roads in nature's walk, need to have a topcoat placed on them. They are cracking and will need to be repaved if they are not repaired soon.*
18. *The goal should be to keep the spirit of volunteerism alive while supplementing it with professional expertise and planning. Homeowners should always feel like participants in something exceptional, not like they're holding together what should be professionally maintained.*
19. *Recognize the men and women that do their best on our behalf to keep Chinquapin pristine and beautiful. We need to let the staff know they are important and appreciated.*


Covenant Administration – Architecture Review

- 43% cited worries about tree removal or over-clearing.
- 27% raised concerns over lighting (uplighting / light pollution).
- 26% mentioned issues with building materials and exterior colors.

Sample Comments

1. Better enforcement of over-clearing; required landscape buffering between road and residence; exterior colors should blend in with surroundings. Consider other, more current building and roofing materials (eg metal, ceramic tile). There should be other options to asphalt shingle.
2. No more White Houses - no grandfathering of current white or bright colored paint. Many property owners leaving numerous outdoor lights on. Too many suburban grass lawns that need to be constantly watered. No more gates. Too many of the same house being built
3. I would love to see more "contemporary" plans being approved. I don't think every house has to be brown, look like a log cabin, or be super rustic to be in the community. If done tasteful and appropriately, a contemporary home can compliment its surroundings beautifully. I do agree with using natural materials, etc.
4. Far too many trees are being removed. Trees should only be removed on a case-by-case basis--no clear cutting. Be consistent--treat everyone the same. Houses should be set back from the road, as was designated in the original building envelopes for each lot. Building materials should be higher quality and exterior colors should be appropriate.
5. We like lighting for security and safety
6. Overabundance of white/cream houses not in keeping with a mountain community

7. *The indiscriminate tree cutting and view corridor clearing is destroying the beauty of the neighborhood. I'm sorry, but I abhor the prevalence of white houses; a house should not be "pop" out of the landscape - they should be as hidden as possible as a goal. As the neighborhood gets more built-out, there is greater light pollution. Lighting should be muted as much as possible. I'm ok with temporary lighting (e.g., spots to help guest) but they should never be left on.*
8. *Excessive tree removal/clear cutting and light pollution both destroy the beauty of the area during the day and at night.*
9. *Tree removal depends if it's a concern of damage to the house. As far as lighting I think it's necessary to some degree due to how dark it is especially at night. Colors are to each is own.*
10. *I agree mostly with the tree removal. The other concerns, lighting and building materials, can be worked out between reasonable parties. However, once mature trees are cut down it takes 30 years to remedy the situation.*
11. *Vetting of builders*
12. *The standards are for everyone not just a few*
13. *I don't understand how white houses can be allowed in the community*
14. *Previous building was not monitored and micromanaged like new buildings it's ridiculous the amount of loops one has to jump to get an approval by people that have no idea about construction or are biased*
15. *Too many similar houses. Builders should be required to mix up exteriors*
16. *Topping tall trees for views versus creating visual windows. Use of composite materials on exterior. Not adhering to policy related to the % of metal roofing to shingle.*
17. *It is critical to keep the building standards high to protect investments.*
18. *Too many black or charcoal homes. Roofing materials should be owners choice.*
19. *One of the things we regret most about our own lot was a poorly managed clearing - where the builder cleared too wide an area from road to house and tree company ignored our request to keep a few large trees in for a filtered view. We see this happening often as lots get started. Completely agree on the lighting - too much, too bright, too harsh. And the main exterior color concern we have is with the white (or almost) houses... in the winter they stick out like sore thumbs vs. the dark natural ones that blend in to the winter cover.*
20. *Houses should be painted in natural colors. No White Houses. Fake rock exteriors. No manufactured houses or you that look manufactured*
21. *Clear cutting of trees and shrubs is altering the natural beauty of Chinquapin and affecting the wildlife and Wolf Lake.*


1. *I just want things to be fair for everyone & standards upheld.*


1. *BYOB*




